Human trafficking, in particular trafficking in minors and young women, for the purpose of sexual exploitation has become over the years one of the main illegal markets worldwide. Italy, a country of destination but also a transit one, is located at the crossroads of two large-scale migration flows, on both the East-West axis as well as on the North-South one.

The extreme ease with which criminal groups adapt to the ever changing globalized international environment, their promptness and dynamism in establishing contacts with criminal groups in other countries, require similar flexibility by States and collaboration among law enforcement authorities, police and intelligence agencies across States boundaries in order to be able to effectively prevent and combat a phenomenon which very often has a transnational dimension.

Nigeria is one of the main origin countries for trafficking of women, often very young girls or even minors, for sexual exploitation in Europe and, in this specific case, in Italy. UNICRI has undertaken a number of initiatives to prevent and combat trafficking from Nigeria to Italy through a pilot project launched in 2002 that lasted for 18 months. This was then followed up by a programme, which started in 2008, whose main results will be presented in Rome in occasion of an important international conference hosted by the Italian Society for International Organisation (SIOI).

The programme "Prevention and Combating Trafficking of Minors and Young Women from Nigeria into Italy," funded by the Directorate General for Development Cooperation of the Italian Ministry of Foreign Affairs, is based on a multidisciplinary and multidimensional strategy, entailing measures to prevent and combat this crime, and to assist victims in the origin country. In addition important activities have been carried out in support to the Nigerian National Agency for Prohibition of Traffic in Persons (NAPTIP) which played a crucial role in the implementation of the programme.
